### **Safety rules**

2. NO ILLEGAL DRUG USE IS ALLOWED IN ANY AREA. USE OF ANY TYPE OR FORM WILL RESULT IN DISQUALIFICATION AND IMMEDIATE REMOVAL FROM THE RANGE.
3. ALL GUNS WILL BE LOADED AND UNLOADED ONLY IN THE DESIGNATED AREAS.
4. RIFLE AND SHOTGUN ACTIONS WILL REMAIN OPEN UNTIL THEY ARE LOADED AS PER THE STAGE DESCRIPTION. PISTOLS WILL REMAIN IN HOLSTERS UNTIL ARRIVAL AT THE FIRING LINE. NO GUN HANDLING BEHIND THE FIRING LINE EXCEPT AT LOADING AND UNLOADING TABLES AND IN DESIGNATED SAFETY AREAS. COLD RANGE RULES APPLY.
5. EYE PROTECTION MUST BE WORN AT ALL TIMES.
6. HEARING PROTECTION IS STRONGLY ENCOURAGED.
